This permit is issued subject to all prior rights. The State reserves the right to regulate the use of the water herein granted at all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed Seven & 6/10 cubic feet per second.

Actual construction work shall begin on or before May 15th, 1914.

Proof of commencement of work shall be filed before June 15th, 1914.

Work must be prosecuted with reasonable diligence and be completed on or before July 15th, 1914.

Application of water to beneficial use shall be made on or before October 15th, 1921

Proof of the application of water to beneficial use must be filed with State Engineer on or before November 15th, 1921.
