The undersigned South Nevada Land & Development Company,
of Las Vegas, County of Clark,
State of Nevada, hereby makes application for
permission to appropriate the public waters of the State of Nevada,
as hereinafter stated. (If applicant is a corporation give date and
place of incorporation.) June 20th, 1912, Carson City, Nevada.

- 1. The source of the proposed appropriation is underground waters
to be brought to the surface by means of artesian or pumping wells.
2. The amount of water applied for is 6.4 second-feet.
3. The water to be used for Irrigation and domestic purposes.
4. The water is to be diverted from its source at the following
point: From artesian or pumping wells situated on the West line of
Section 3, of T. 21 S.R. 61 E., M.D.B & M., the exact loci of
wells depending upon development. Wells also to be sunk along the
West Line of section 4 same Township & Range.

IF THE WATER IS TO BE USED FOR IRRIGATION, SUPPLY THE FOLLOWING INFORMATION:

- (a) Number of acres to be irrigated is 640
(b) Description of land to be irrigated Sections 3 and 4, T. 21
S.R. 61 E., M.D.B & M.

- (c) Irrigation will begin about January 1st and end about
December 31st, of each year.

DESCRIPTION OF PROPOSED WORKS

Water to be diverted from underground source by wells artesian or pumping in iron screw casing 12" and 8" diam. To be conveyed over land by means of concrete and earth ditches.

6. Estimated time required to construct works Four years.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed Six & 4/10 cubic feet per second. (6.4)

Actual construction work shall begin on or before May 19, 1915.

Proof of commencement of work shall be filed before June 19, 1915.

Work must be prosecuted with reasonable diligence and be completed on or before May 19, 1919.

Application of water to beneficial use shall be made on or before November 19, 1921. Proof of the application of water to beneficial use must be filed with State Engineer on or before December 19, 1921.
