This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: (See attached sheet)

This permit is issued subject to all prior rights on the source and particularly subject to the right of William Schodde as granted in permit No. 2743, and is for water for the following described land: 40 acres in the SE 1/4 of the SE 1/4 of Sec. 15 and 80 acres in the S 1/2 of the SW 1/4 of Sec. 14, all in T. 35 N. R. 62 E., M.D.B. & M., making a total of 120 acres.

This application being made in conjunction with applications Nos. 3212 to 3223 inclusive, all of which applications were made with the view of collecting the waters of numerous creeks in a common ditch, the permit herewith issued is considered a part only of the irrigation system proposed under the above named applications. Therefore the water herein granted for 120 acres of land in specific subdivisions, may also be used on lands named in permits Nos. 3219 to 3223 inclusive, lying under the ditch system below this point of confluence of the creek with the diversion canal.

The State reserves the right to regulate the use of the water herein granted at all times.
