TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The undersigned W.D. Peregon, Tom Thornberry, H. Westgard and Earnest McKinney, Name of applicant. of Rochester, County of Humboldt, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation give date and place of incorporation.)

- 1. The source of the proposed appropriation is Spring in Buffalo Canyon. Name of stream, lake, or other source.
2. The amount of water applied for is one-half (1/2) second-feet. One second-foot equals 40 miners' inches.
3. The water to be used for Mining and domestic purposes. Irrigation, power, mining, manufacturing, domestic, or other use.
4. The water is to be diverted from its source at the following point: on NW 1/4 of NW 1/4 of Sec. 10, T. 27 N.R. 34 E., M.D.B & M. Describe as being within a 40-acre subdivision of public survey, or by course and distance to a section corner. If on unsurveyed land it should be so stated. Point of diversion bears S. 23° 30' E., 1065 ft., from NW Cor. Sec. 10.

IF THE WATER IS TO BE USED FOR IRRIGATION, SUPPLY THE FOLLOWING INFORMATION:

(e) Works to be located on SW 1/4 of NE 1/4 Sec. 9, T. 27 N.R. 34 E., M.D.B & M. Give 40-acre subdivision on which works will be located, or locate by course and distance to a section corner.
(f) Point of return of water to stream none Describe in same manner as point of diversion.
(g) Remarks The Canyon in which this point of diversion is situate is the first canyon south of the one in which the point of diversion described in application No. 2606 is situate. The aforesaid point of diversion as described by course and distance is liable to vary slightly as the water will have to be developed.

DESCRIPTION OF PROPOSED WORKS

Water to be diverted through pipe.

This permit is issued subject to all prior rights on the source.

The State reserves the right to regulate the use of the water herein granted at all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed one-half cubic feet per second. (0.5)

Actual construction work shall begin on or before December 27, 1915.

Proof of commencement of work shall be filed before January 27, 1916.

Work must be prosecuted with reasonable diligence and be completed on or before June 27, 1917.

Application of water to beneficial use shall be made on or before June 27, 1918. Proof of the application of water to beneficial

use must be filed with State Engineer on or before July 27, 1918.
