permission to appropriate the public waters of the State of Nevada,
as hereinafter stated. (If applicant is a corporation give date and
place of incorporation.) January 1909- State of Utah.

The source of the proposed appropriation is 3 springs
on NW 1/4 of NE 1/4 Sec. 27, T. 44 N., R. 62 E., and one on SW 1/4 of SE 1/4, Sec. 22,
T. 44 N., R. 62 E., M.D.B. & M.

The amount of water applied for is one-quarter second-feet.
(One second-foot equals 40 miners' inches.)

The water to be used for Watering stock and irrigating.
Irrigation, power, mining, manufacturing, domestic, or other use.

The water is to be diverted from its source at the following
point: SW 1/4 of SE 1/4, Sec. 22, T. 44 N., R. 62 E., M.D.B. & M.
Describe as being within a 40-acre subdivision of public survey, or by course and distance to a section corner. If on unsurveyed land it should be so stated

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all prior rights on the source.

The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed One fourth cubic feet per second. (0.25)

Actual construction work shall begin on or before May 20, 1916.

Proof of commencement of work shall be filed before June 20, 1916.

Work must be prosecuted with reasonable diligence and be completed on or before May 20, 1917.

Application of water to beneficial use shall be made on or before May 20, 1918.

Proof of the application of water to beneficial use must be filed with State Engineer on or before June 20, 1918.
