This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This Permit is issued subject to all vested rights and prior rights for storage on Black Jack Wash or any stream of which it may be considered tributary. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed PER ANNUM.

Actual construction work shall begin on or before October 1, 1931

Proof of commencement of work shall be filed before November 1, 1931

Work must be prosecuted with reasonable diligence and be completed on or before October 1, 1932

Proof of completion of work shall be filed before November 1, 1932

Application of water to beneficial use shall be made on or before October 1, 1936

Proof of the application of water to beneficial use must be filed with State Engineer on or before November 1, 1936
