Proof of commencement of work shall be filed before June 28, 1927

Work must be prosecuted with reasonable diligence and be completed on or before May 28, 1928

Proof of completion of work shall be filed before June 28, 1928

Application of water to beneficial use shall be made on or before May 28, 1929. Proof of the application of water to beneficial

use must be filed with State Engineer on or before June 28, 1929
