DESCRIPTION OF PROPOSED WORKS

Spring to be dug out and water conducted through a pipe to State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits. If water about 40 ft. of iron troughs to be located about 15 ft. south is to be stored in reservoirs, it should be so stated and the location of the reservoir should be given with reference to the legal subdivisions of the point of diversion.

This Permit is issued subject to all prior rights on the source. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.03 or sufficient to water 5000 head of sheep. cubic feet per second.

Actual construction work shall begin on or before April 1, 1930

Proof of commencement of work shall be filed before May 1, 1930

Work must be prosecuted with reasonable diligence and be completed on or before April 1, 1931

Proof of completion of work shall be filed before May 1, 1931

Application of water to beneficial use shall be made on or before

April 1, 1933

Proof of the application of water to beneficial use must be filed with State Engineer on or before May 1, 1933
