This Permit is issued subject to all prior rights on the source. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed .03 cubic feet per second.

Actual construction work shall begin on or before Oct. 1, 1930

Proof of commencement of work shall be filed before Nov. 1, 1930

Work must be prosecuted with reasonable diligence and be completed on or before Oct. 1, 1932

Proof of completion of work shall be filed before Nov. 1, 1932

Application of water to beneficial use shall be made on or before Oct. 1, 1933

Proof of the application of water to beneficial use must be filed with State Engineer on or before Nov. 1, 1933
