

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all prior rights on the source. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed .016 cubic feet per second.

Actual construction work shall begin on or before July 1, 1938

Proof of commencement of work shall be filed before August 1, 1938
