TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The undersigned A. L. DRESSLER
of Denio, County of Harney, State of Oregon, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation.)

- 1. The source of the proposed appropriation is Big Alder Creek and Springs and Tributaries.
2. The amount of water applied for is 0.5 second-feet.
3. The water to be used for stockwatering and domestic purposes.
4. The water is to be diverted from its source at the following point: At a point approximately in the NW 1/4 SW 1/4 Sec. 3, T. 43 N., R. 28 E., unsurveyed, which bears S. 75° 58' 30" W., 15163.67 feet, from the SE Cor. of T. 44 N., R. 28 E.

IF THE WATER IS TO BE USED FOR IRRIGATION, SUPPLY THE FOLLOWING INFORMATION:

- (a) Number of acres to be irrigated is
(b) Description of land to be irrigated
(c) Use will begin about and end about, of each year.

IF WATER IS TO BE USED FOR POWER, MINING, STOCK WATERING, OR OTHER USE, SUPPLY THE FOLLOWING INFORMATION:

- (d) Power to be developed is horsepower.
(e) Works to be located at a point approximately in the NW 1/4 SW 1/4 Sec. 3, T. 43 N., R. 28 E., unsurveyed.
(f) Point of return of water to stream
(g) State number and kinds of animals to be watered 6000 sheep and 800 cattle.
(h) Use will begin about Jan. 1 and end about Dec. 31, of each year.

(i) Remarks Applicant and his predecessors in interest have used the water from these sources for watering stock, and said stock has been grazed on and used all of the available range adjacent to these sources for many years prior to 1905, and therefore such vested rights as have been initiated thereby, which said rights are claimed by this applicant, are not waived by virtue of the filing of this application.

DESCRIPTION OF PROPOSED WORKS

A dam, or dams, will be constructed of earth and rock to facilitate State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits. If water stockwatering.

is to be stored in reservoirs, it should be so stated and the location of the reservoir should be given with reference to the legal subdivisions.

5. Estimated cost of works \$200.00

6. Estimated time required to construct works one year

7. Remarks Owing to rulings to the effect that the water law does not provide a means for the State Engineer to determine vested rights for stockwatering purposes, this application has been filed as the simplest and most convenient means of perfecting record title and right to the use of water from the source named herein.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This Permit is issued subject to all prior rights on the source. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed .0625 or sufficient to water 6000 head of sheep and 800 head of cattle, cubic feet per second.

Actual construction work shall begin on or before Nov. 1, 1930

Proof of commencement of work shall be filed before Dec. 1, 1930

Work must be prosecuted with reasonable diligence and be completed on or before Nov. 1, 1931

Proof of completion of work shall be filed before Dec. 1, 1931

Application of water to beneficial use shall be made on or before

Nov. 1, 1933. Proof of the application of water to beneficial

use must be filed with State Engineer on or before Dec. 1, 1933
