provision of law at the present time for the determination of vested
stockwatering rights by the State Engineer.

DESCRIPTION OF PROPOSED WORKS

Pipe line and troughs of this company already located at the spring State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.
