This is to certify that I have examined the foregoing application and do hereby deny the same, subject to the following limitations and conditions: On the grounds that the applicant or his successor in interest failed to submit the requested information, including an intent to place the water to be appropriated to a beneficial use, necessary before a permit could be issued under this application.
