This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all prior rights on the source. A valve must be installed and maintained to prevent waste of water, and accurate measurements of water placed to beneficial use must be taken from time to time. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.20 of a cubic feet per second.

Actual construction work shall begin on or before July 1, 1941

Proof of commencement of work shall be filed before August 1, 1941

Work must be prosecuted with reasonable diligence and be completed on or before July 1, 1943

Proof of completion of work shall be filed before August 1, 1943

Application of water to beneficial use shall be made on or before July 1, 1944

Proof of the application of water to beneficial use must be filed with State Engineer on or before August 1, 1944
