

DESCRIPTION OF PROPOSED WORKS

Drilled well, with 6 5/8 and 4 5/8 casing, water to be pumped by windmill and stored in tank of approximately 5,000 gallons capacity, and turned into stockwatering through through pipe, to be located at the place of diversion close by the well. Tank and trough to be made of steel. Trough 24 inches wide and 12 inches deep. 1 1/2 inch pipe to be used.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all prior rights on the source. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.011 of a cubic feet per second, or sufficient to water 350 head of cattle.

Actual construction work shall begin on or before December 8, 1943

Proof of commencement of work shall be filed before January 8, 1944

Work must be prosecuted with reasonable diligence and be completed on or before December 8, 1945

Proof of completion of work shall be filed before January 8, 1946

Application of water to beneficial use shall be made on or before December 8, 1946. Proof of the application of water to beneficial use must be filed with State Engineer on or before January 8, 1947
