

This permit is issued subject to all prior rights on the source.

The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.004 of a cubic foot per second, or sufficient to water 125 head of cattle and horses

Actual construction work shall begin on or before January 22, 1944

Proof of commencement of work shall be filed before February 22, 1944

Work must be prosecuted with reasonable diligence and be completed on or before January 22, 1946

Proof of completion of work shall be filed before February 22, 1946

Application of water to beneficial use shall be made on or before January 22, 1947

Proof of the application of water to beneficial use must be filed with State Engineer on or before February 22, 1947
