

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source and also subject to the conditions set forth in the ruling of the State Engineer, dated April 29, 1949 as applied to this source of water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.003

cubic feet per second, or sufficient to water 100 head of cattle from April 1 to November 30 of each year.

Actual construction work shall begin on or before November 18, 1949

Proof of commencement of work shall be filed before December 18, 1949

Work must be prosecuted with reasonable diligence and be completed on or before November 18, 1950

Proof of completion of work shall be filed before December 18, 1950

Application of water to beneficial use shall be made on or before

November 18, 1951. Proof of the application of water to beneficial

use must be filed with State Engineer on or before December 18, 1951
