hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation.)

1. The source of the proposed appropriation is underground Lake bed. Name of stream, lake, or other source

2. The amount of water applied for is 0.75 second-feet. One second-foot equals 40 miners' inches

3. The water to be used for quasi municipal and domestic Irrigation, power, mining, manufacturing, domestic, or other use

4. The water is to be diverted from its source at the following point: S 1/2 of Tract 37, being a subdivision of fractional Sec. 8, T. 27 S., R. 59 E., M.D.B.&M., at a point which bears N. 23° 59' W., 1,220 ft. from Cor. No. 4 of said Tract 37.

IF THE WATER IS TO BE USED FOR IRRIGATION, SUPPLY THE FOLLOWING INFORMATION:

(a) Number of acres to be irrigated is 164.8 acres



APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all prior rights. It is understood that the 0.75 c.f.s. of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependant upon the amount of water actually placed to a beneficial use. A suitable measuring device must be installed and measurements of water placed to beneficial use must be included in the proof of such use when filed. The State reserves the right to regulate the use of the waters herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.75 cubic feet per second.

Actual construction work shall begin on or before July 29, 1946

Proof of commencement of work shall be filed before August 29, 1946

Work must be prosecuted with reasonable diligence and be completed on or before July 29, 1949

Proof of completion of work shall be filed before August 29, 1949

Application of water to beneficial use shall be made on or before July 29, 1950. Proof of the application of water to beneficial

use must be filed with State Engineer on or before August 29, 1950.
