This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all prior rights. The State reserves the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0046 cubic feet per second, or sufficient to water 150 head of cattle.

Actual construction work shall begin on or before January 5, 1947

Proof of commencement of work shall be filed before February 5, 1947

Work must be prosecuted with reasonable diligence and be completed on or before January 5, 1948

Proof of completion of work shall be filed before February 5, 1948

Application of water to beneficial use shall be made on or before January 5, 1948

Proof of the application of water to beneficial use must be filed with State Engineer on or before February 5, 1948
