This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to any existing rights on the source. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed sufficient water to water 200 head of cattle.

Actual construction work shall begin on or before March 18, 1948

Proof of commencement of work shall be filed before April 18, 1948

Work must be prosecuted with reasonable diligence and be completed on or before March 18, 1949

Proof of completion of work shall be filed before April 18, 1949

Application of water to beneficial use shall be made on or before

March 18, 1950. Proof of the application of water to beneficial

use must be filed with State Engineer on or before April 18, 1950
