The undersigned BARTHOLOMAE CORPORATION
of Fullerton, County of Orange, State of California, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation.) March 30, 1923; California

- 1. The source of the proposed appropriation is Antelope Valley Channel Diversion No. 2, Eureka County, Nevada.
2. The amount of water applied for is 1 second-feet.
3. The water to be used for Stockwatering
4. The water is to be diverted from its source at the following point: in the NW 1/4 SW 1/4 Section 24, T. 16 N., R. 50 E., unsurveyed whence the Northeast corner of said Section 24 bears N. 62 degrees E., 5930 feet distant.

(h) Use will begin about Jan. 1st and end about Dec. 31st, of each year.

DESCRIPTION OF PROPOSED WORKS

Water will be diverted by constructing earthen dams across the channel. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits. If water is to be stored in reservoirs, it should be so stated and the location of the reservoir should be given with reference to the legal subdivisions. Water will be stored in reservoirs. Dams and reservoirs will be constructed in the NW 1/4 SW 1/4 Section 24, T. 16 N., R. 50 E., Unsurveyed and in the NW 1/4 NW 1/4 Section 7, T. 16 N., R. 51 E., M.D.B.&M.

- 5. Estimated cost of works \$100.00 for the dam and reservoir in Section 24 at Diversion No. 2
6. Estimated time required to construct works 24 months.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0094 cubic feet per second., or sufficient to water 300 head of cattle.

Actual construction work shall begin on or before April 16, 1951

Proof of commencement of work shall be filed before May 16, 1951

Work must be prosecuted with reasonable diligence and be completed on or before April 16, 1952

Proof of completion of work shall be filed before May 16, 1952

Application of water to beneficial use shall be made on or before April 16, 1953. Proof of the application of water to beneficial

use must be filed with State Engineer on or before May 16, 1953
