DESCRIPTION OF PROPOSED WORKS

State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits. If water is to be stored in reservoirs, it should be so stated and the location of the reservoir should be given with reference to the legal subdivisions.

Irrigation worked out on this plan provides that three pump wells be connected by a ditch which will divert the water over the entire 320 acres.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the water right must allow for a reasonable lowering of the static water level at permittees well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, and not to exceed a duty of 4.0 acre-feet per acre irrigated.

Actual construction work shall begin on or before July 14, 1950

Proof of commencement of work shall be filed before August 14, 1950

Work must be prosecuted with reasonable diligence and be completed on or before July 14, 1951

Proof of completion of work shall be filed before August 14, 1951

Application of water to beneficial use shall be made on or before July 14, 1953

Proof of the application of water to beneficial use must be filed with State Engineer on or before August 14, 1953
