APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights and also subject to that certain agreement dated March 3, 1950 between the permittee herein, and other users of water from the same source regarding equal priorities on file in the Office of State Engineer. A substantial weir or other type of measuring device must be installed and maintained to facilitate the measurement and control of water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 6.4

cubic feet per second, and not to exceed a seasonal duty of 4 acre-feet of water per acre of land irrigated.

Actual construction work shall begin on or before October 10, 1950

Proof of commencement of work shall be filed before November 10, 1950

Work must be prosecuted with reasonable diligence and be completed on or before October 10, 1951

Proof of completion of work shall be filed before November 10, 1951

Application of water to beneficial use shall be made on or before

October 10, 1952. Proof of the application of water to beneficial

use must be filed with State Engineer on or before November 10, 1952
