APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use of the waters of the Humboldt River as heretofore granted under Permit No. 9734 is issued subject to the terms and conditions imposed in said Permit No. 9734 and with the understanding that no other rights on the source will be affected by the change proposed herein. It is further understood that this permit is subject to the provisions set forth in that certain ruling dated May 24, 1950 pertaining to this application, and that the proof of beneficial use, when filed, must be supported by a cultural map together with data sufficient to show the amount of water actually transferred. The State retains the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use and not to exceed 3,023.49 acre feet per season, and the following flows during the periods indicated:

March 15 to April 28	9.911 c.f.s.
April 28 to June 13	7.633 c.f.s.
June 13 to Sept. 15	7.616 c.f.s.

Actual construction work shall begin on or before November 16, 1950

Proof of commencement of work shall be filed before December 16, 1950

Work must be prosecuted with reasonable diligence and be completed on or before November 16, 1952

Proof of completion of work shall be filed before December 16, 1952

Application of water to beneficial use shall be made on or before November 16, 1955. Proof of the application of water to beneficial

use must be filed with State Engineer on or before December 16, 1955
