

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the water rights must allow for a reasonable lowering of the static water level at permittees well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.055

cubic feet per second; irrigation purposes from all sources shall not exceed 5 acre-feet per annum.

Actual construction work shall begin on or before May 21, 1951

Proof of commencement of work shall be filed before June 21, 1951

Work must be prosecuted with reasonable diligence and be completed on or before May 21, 1952

Proof of completion of work shall be filed before June 21, 1952

Application of water to beneficial use shall be made on or before May 21, 1953

Proof of the application of water to beneficial use must be filed with State Engineer on or before June 21, 1953
