DESCRIPTION OF PROPOSED WORKS

It is proposed to divert water through a 10" drilled well pumped into stand pipes for filling tank trucks which will water race track

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: the source. A valve must be installed and maintained to prevent waste of water. A meter must be installed in the pipe line near the point of diversion, so that accurate measurements of water placed to beneficial use may be obtained. This source is located within an area that has been designated by the State Engineer as coming within the meaning of the provisions of the 1939 Underground Water Act as amended in 1943; the State has the right to regulate the use of the water herein granted at any and all times. It is further understood that the yearly amount of water used from wells under Permits 13278, 13368, 13369 and 13370 shall be limited to 550 acre-feet annually. The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.5 cubic feet per second.

Actual construction work shall begin on or before January 25, 1951

Proof of commencement of work shall be filed before February 25, 1951

Work must be prosecuted with reasonable diligence and be completed on or before January 25, 1952

Proof of completion of work shall be filed before February 25, 1952

Application of water to beneficial use shall be made on or before

January 25, 1954. Proof of the application of water to beneficial

use must be filed with State Engineer on or before February 25, 1954
