DESCRIPTION OF PROPOSED WORKS

Water to be diverted from a 10" gravel packed cased artesian well and distributed by a system of pipe lines to various places of use. Pumping facilities will be installed to develop water, together with necessary valves for control purposes.

7. Remarks The water derived from this well will be co-mingled with

the other appropriated water from wells situated within the NE 1/4 of Sec. 16, T. 21 S., R. 61 E., wherein will be located the 18 hole Golf course and other extensive improvements and the necessary water is planned to be put to beneficial use.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. If well is flowing, a valve must be installed and maintained to prevent waste. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level at permittees well due to other ground water development in the area. This source is located within an area designated by the State Engineer pursuant to Section 4 of the 1939 Ground-Water Act (Chap. 178, Stats. 1939 as amended 1949); therefore the State retains the right to regulate the use of the water herein granted at any and all times. The amount of water to be appropriated shall be limited to the amount

which can be applied to beneficial use, and not to exceed 0.8 cubic feet per second, with the understanding that the yearly use of water per acre of land shall not exceed 4 acre-feet.

Actual construction work shall begin on or before January 27, 1952

Proof of commencement of work shall be filed before February 27, 1952

Work must be prosecuted with reasonable diligence and be completed on or before January 27, 1954

Proof of completion of work shall be filed before February 27, 1954

Application of water to beneficial use shall be made on or before

January 27, 1956. Proof of the application of water to beneficial

use must be filed with State Engineer on or before February 27, 1956
