of 15 W. 2nd Street, Reno, County of Washoe, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

- 1. The source of the proposed appropriation is underground
2. The amount of water applied for is 3.2 second-feet.
3. The water to be used for irrigation and domestic
4. The water is to be diverted from its source at the following point: About Center NW 1/4 Section 15, T. 17 S., R. 49 E.
