This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of 1.5 c.f.s. of the waters of the Truckee River as set forth in the Truckee River Final Decree as entered by the U. S. District Court of Nevada, Case in Equity, Docket A-3, vested under Claim No. 384, is issued subject to the terms and conditions of said Decree and with the further understanding that no other rights on the source will be impaired by the change proposed herein. A substantial headgate, weir or other suitable measuring device must be installed at or near the new point of diversion to facilitate the measurement and control of water.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.5 cubic feet per second.

Actual construction work shall begin on or before December 18, 1956

Proof of commencement of work shall be filed before January 18, 1957

Work must be prosecuted with reasonable diligence and be completed on or before December 18, 1957

Proof of completion of work shall be filed before January 18, 1958

Application of water to beneficial use shall be made on or before December 18, 1957

Proof of the application of water to beneficial use must be filed with State Engineer on or before January 18, 1958

Proof of commencement of work filed DEC 7 1956
