The undersigned W. E. Herrmann Name of applicant
of Rural Route 1, Suisun, County of Solano, State of California, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation.)

- 1. The source of the proposed appropriation is Underground Name of stream, lake, or other source
2. The amount of water applied for is 5.0 second-feet. One second-foot equals 40 miners' inches
3. The water to be used for Irrigation and Domestic Irrigation, power, mining; manufacturing, domestic, or other use
4. The water is to be diverted from its source at the following point: In the NE 1/4 NE 1/4 Section 19, T. 16 N., R. 22 E., from which the North-east Corner of Sec. 19 bears N. 0° 10' E., 1207.0 feet.

IF THE WATER IS TO BE USED FOR IRRIGATION, SUPPLY THE FOLLOWING INFORMATION:

- (a) Number of acres to be irrigated is 400
(b) Description of land to be irrigated N 1/2 NE 1/4 Sec. 19; N 1/2 NW 1/4 Sec. 20; E 1/2 SW 1/4 & SE 1/4 Sec. 18; W 1/2 & SE 1/4 Sec. 17, T. 16 N., R. 22 E., M.D.B.&M.

- (c) Use will begin about Jan. 1 and end about Dec. 31, of each year.

IF WATER IS TO BE USED FOR POWER, MINING, STOCK WATERING, OR OTHER USE, SUPPLY THE FOLLOWING INFORMATION

- (d) Power to be developed is horsepower.
(e) Place of use Give location of place of use by legal subdivision.

(i) Remarks Water from this well will be comingled with the waters from other well to irrigate the same lands or separate lands. This water will also supplement rights from the Carson River.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source and is limited to what the well will produce but not to exceed 5.0 c.f.s. It is understood that this right must allow for a reasonable lowering of the static water level at permittees well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept, and a method provided, either air line or opening, for measuring depth to water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.0

cubic feet per second, or a yearly duty of 4 acre-feet per acre of land irrigated.

Actual construction work shall begin on or before September 20, 1957

Proof of commencement of work shall be filed before October 20, 1957

Work must be prosecuted with reasonable diligence and be completed on or before September 20, 1958

Proof of completion of work shall be filed before October 20, 1958

Application of water to beneficial use shall be made on or before

September 20, 1962. Proof of the application of water to beneficial

use must be filed with State Engineer on or before October 20, 1962
