2. The quantity of water desired to be changed 1.60 c.f.s. or 678 ac. ft. (Acre feet, second feet.)

which the north one quarter of said section 17 bears N. 6°59'30"W.,
3883.40 feet. (Describe as being within a 40-acre subdivision of public survey or by course and distance to a section corner.)

- 8. The existing point of diversion under the former appropriation is
SE 1/4 SW 1/4 of Sec. 8, T. 27 N., R. 48 E. or at a point that
as follows: bears S. 36° 00' E. 11,700 Feet from NW corner of Sec. 6,
T. 27 N., R. 48 E. (If point of diversion is not changed do not answer.)

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of Mill Creek as heretofore granted under Permit No. 6312, is issued subject to the terms and conditions imposed in said Permit No. 6312 and with the understanding that no other rights on the source will be affected by the change proposed herein. A substantial headgate and weir must be installed at or near the new point of diversion to facilitate the measurement and control of water. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The quantity of water to be changed shall be limited to the amount which can be applied to beneficial use and not to exceed 1.6 c.f.s., or 678 acre-feet per season.

Actual construction work shall begin on or before July 28, 1959

Proof of commencement of work shall be filed before August 28, 1959

Work must be prosecuted with reasonable diligence and be completed on or before July 28, 1960

Proof of completion of work shall be filed before August 28, 1960

Application of water to beneficial use shall be made on or before

July 28, 1963. Proof of the application of water to beneficial

use must be filed with State Engineer on or before August 28, 1963
