

AMENDED APPLICATION FOR PERMIT

TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Harrah Club, Inc. of 210 N. Virginia St. Reno, County of Washoe State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Incorporated on July 1, 1952 in Carson City, Nevada. 1. The source of the proposed appropriation is Underground (Well No. 2) Name of stream, lake or other source.

2. The amount of water applied for is 0.25 c.f.s. second-feet. One second-foot equals 448.83 gals. per min.

5. The water is to be diverted from its source at the following point: NW 1/4 SE 1/4 Sec. 27, T. 13 N., R. 18 E., M.D.B.&M., or at a point from which the S.E. corner of said Sec. 27 bears S. 44° 18' 11" E., 2973.04 feet.

6. Place of use NW 1/4 SE 1/4 Sec. 27, T. 13 N., R. 18 E., M.D.B.&M.

7. Use will begin about January 1 and end about December 31, of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source and is limited to what the well will produce but not to exceed 0.25 c.f.s. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level at permittees well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept, and a method provided, either air line or opening, for measuring depth to water. The State retains the right to regulate the use of the water herein granted at any and all times. The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second.

- Actual construction work shall begin on or before October 14, 1960
- Proof of commencement of work shall be filed before November 14, 1960
- Work must be prosecuted with reasonable diligence and be completed on or before October 14, 1961
- Proof of completion of work shall be filed before November 14, 1961
- Application of water to beneficial use shall be made on or before October 14, 1962
- Proof of the application of water to beneficial use shall be filed on or before November 14, 1962
- Map in support of proof of beneficial use shall be filed on or before.....
