

AMENDED APPLICATION FOR PERMIT

TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Mrs. Alberta June Morrison (c/o Robert Leland, Atty. 206 N. Virginia St., Reno) of Orillia, County of King, State of Washington, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is underground water. Name of stream, lake or other source.

2. The amount of water applied for is five and four tenths (5.4) c.f.s. second-feet. One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet. acre-feet.

3. The water to be used for irrigation and domestic use. Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 320 acres.

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 11. Remarks")

(d) Power:

(1) Horsepower developed 100 H. P. diesel driven pump.

(2) Point of return of water to stream Seepage

5. The water is to be diverted from its source at the following point: in the SE 1/4 SW 1/4 Sec. 34.


