APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to all existing rights on the source. It is limited to what the well will produce but not to exceed 5.4 c.f.s., and must be used in conjunction with present water supplies. It is understood that this right must allow for a reasonable lowering of the static water level due to other ground water development, that the water granted under this permit is limited to supplemental use and is appurtenant to the 440 acres having existing water rights, and that the duty of water from all sources shall not exceed 1,760 acre-feet annually. A substantial measuring device must be installed and measurements of water use kept, and a method provided, either air line or opening, for measuring depth to water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, or a yearly duty of 4.0 acre-feet per acre of land irrigated.
