The applicant WILBUR CLARK'S DESERT INN of Las Vegas, County of Clark

State of Nevada, hereby makes application for permission to change the Point of diversion and place of use

of water heretofore appropriated under Permit No. 16940, Certificate No. 4767

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

1. The source of water is an underground source in Las Vegas Artesian Basin, Clark County, Nev (Name of stream, lake or other source.)

2. The amount of water to be changed 0.34 c.f.s., not to exceed 272 ac.ft.annually (Second feet, acre feet.)

3. The water to be used for Recreational (Golf Course) - irrigation (If for stock state number and kind of animals.)

4. The water heretofore used for Recreational (Golf Course) and domestic (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point within the SW 1/4 NE 1/4 Sec. 14, T. 21 S., R. 61 E., MD.M. or at a point from which the North 1/4 corner of said Sec. 14 bears North 9°19' West a distance of 2180 feet. (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

6. The existing point of diversion is located within Permit No. 16940, Certificate No. 4767, within NE 1/4 NE 1/4 Sec. 16, T. 21 S., R. 61 E., M.D.B.&M., or at a point from which the NE corner of said Sec. 16 bears N.44°52'E.,283 feet. (If point of diversion is not changed, do not answer.)

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit No. 16940, Certificate No. 4767, is issued subject to the terms and conditions imposed in said Permit No. 16940, Certificate No. 4767 and with the understanding that no other rights on the source will be affected by the change proposed herein. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. The well under Permit No. 16940, Certificate No. 4767 must be sealed from the bottom up in accordance with the State Engineer's specifications. The State reserves the right to regulate the use of the water under this proposed change at any and all times. The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.34 cubic feet per second, or 272 acre-feet annually.

Actual construction work shall begin on or before July 6, 1961

Proof of commencement of work shall be filed before August 6, 1961

Work must be prosecuted with reasonable diligence and be completed on or before July 6, 1962

Proof of completion of work shall be filed before August 6, 1962

Application of water to beneficial use shall be made on or before July 6, 1963

Proof of the application of water to beneficial use shall be filed on or before August 6, 1963

Map in support of proof of beneficial use shall be filed on or before August 6, 1963
