

APPLICATION FOR PERMIT TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant Cleo Anderson of Tulare, County of Hand, State of South Dakota, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground Name of stream, lake or other source.

2. The amount of water applied for is 6 second ft. second-feet. One second-foot equals 448.83 gals. per min.

The water is to be diverted from its source at the following point: SW 1/4 of SW 1/4 Sec 1 T. 24 N R. 41 E at a point which bears N 45° 00' E 70.7 ft. from the SW cor. of Sec. 1, T 24 N, R 41 E, M.D.B.&M. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use South 1/2 Section 1 T. 24 N R. 41 E NE 1/4 SE 1/4 NW 1/4 SE 1/4 SE 1/4 SE 1/4 SW 1/4 SE 1/4 NE 1/4 SW 1/4 NW 1/4 SW 1/4 SE 1/4 SW 1/4 SW 1/4 of Sec 1, T 24 N, R. 41 E, M.D.B.&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source and is limited to what the well will produce but not to exceed 5.4 c.f.s. It is understood that this right must allow for a reasonable lowering of the static water level at permittee's well due to other ground water development in the area. A substantial weir or other type of measuring device must be installed and measurements of water use kept, and a method provided, either air line or opening, for measuring depth to water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, or a yearly duty of 4.0 acre-feet per acre of land irrigated.
