The applicant BERTRAND ARAMBEL of Eureka, County of Eureka, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underwood (Wild Indian Spring) Name of stream, lake or other source.

2. The amount of water applied for is 0.05 second-feet One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Stockwatering Irrigation, power, mining, manufacturing, domestic, or other use.

Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use SW 1/4 NW 1/4 Section 2, Township 14 North, Range 51 East, M.D.B.&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about April 15 and end about October 1, of each year. Month Month
