The applicant SIERRA PACIFIC POWER COMPANY of RENO, County of WASHOE

State of NEVADA, hereby makes application for permission to change the Point of diversion, place of use and manner of use of a portion

of water heretofore appropriated under Claim No. 169 of the Truckee River Decree (The United States of America, Plaintiff, vs. Orr Water Ditch Company, et al., Defendants, the same in Equity Docket No. A-3).

1. The source of water is Truckee River. (Name of stream, lake or other source.)

2. The amount of water to be changed 0.176 c.f.s. not to exceed 43 A.F. per season. (Second feet, acre feet.)

3. The water to be used for Municipal and Domestic. (If for stock state number and kind of animals.)

4. The water heretofore used for Irrigation, Domestic and Stock Watering. (If for stock state number and kind of animals.)

5. The water is to be diverted at the following point In the SE 1/4 NE 1/4 of Sec. 16, T. 19 N., R. 19 E., M.D.B.&M. /at a point from which the northeast corner of said Section 16 bears N. 26° 30' E., 1702.0 feet (Reno Power Ditch).

6. The existing point of diversion is located within The SE 1/4 NE 1/4 of Sec. 14, T. 19 N., R. 18 E., M.D.B.&M. /at a point from which the northeast corner of said Section 14 bears N. 24° 26' E., 1840.0 ft. (Last Chance Ditch).

7. Proposed place of use. (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.) S 1/2 Sec. 31, S 1/2 Sec. 32, S 1/2 Sec. 33, T. 20 N., R. 20 E. This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner and place of use of the waters of the Truckee River as heretofore granted under Claim No. 169, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.176 cubic feet per second, or not to exceed 43 acre-feet per season.

Actual construction work shall begin on or before December 5, 1961

Proof of commencement of work shall be filed before January 5, 1962

Work must be prosecuted with reasonable diligence and be completed on or before December 5, 1962

Proof of completion of work shall be filed before January 5, 1963

Application of water to beneficial use shall be made on or before December 5, 1963

Proof of the application of water to beneficial use shall be filed on or before January 5, 1964
