APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights and is further subject to revocation when water is available from the Las Vegas Valley Water District. The water must be developed below the blue clay and no perforations of the casing will be allowed above this sealing strata. The permit is limited to what the well will produce but not to exceed 1.0 c.f.s. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level. This source is located within an area designated by the State Engineer pursuant to NRS 534.030; therefore, the State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second.

Actual construction work shall begin on or before June 22, 1962
Proof of commencement of work shall be filed before July 22, 1962
Work must be prosecuted with reasonable diligence and be completed on or before June 22, 1963
Proof of completion of work shall be filed before July 22, 1963
Application of water to beneficial use shall be made on or before June 22, 1964
Proof of the application of water to beneficial use shall be filed on or before July 22, 1964
Map in support of proof of beneficial use shall be filed on or before July 22, 1964
