State of Nevada, hereby makes application for permission to change the
Point of Diversion, Manner of Use and Place of Use
of water heretofore appropriated under Proof No. 02474 (Well No. 271)

- The source of water is Las Vegas Artesian Basin (underground source)

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion, manner of use and place of use of the waters of an underground source as heretofore granted under Proof of Appropriation No. 02474, is issued subject to the terms and conditions imposed in said Proof of Appropriation No. 02474 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well under this proof must be properly sealed under supervision of the Las Vegas Branch office, Division of Water Resources within six months of the issuance of this permit. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. The State reserves the right to regulate the use of the water under this proposed change at any and all times.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed.....0.25.....cubic feet per second, not to exceed a total duty of 1,100 acre-feet from all sources supplying the place of use.

Actual construction work shall begin on or before.....April 22, 1963

Proof of commencement of work shall be filed before.....May 22, 1963

Work must be prosecuted with reasonable diligence and be completed on or before.....April 22, 1964
