The applicant Alfred R. Dole of 93 Parkside Drive, Berkeley, County of Alameda State of California, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground Name of stream, lake or other source.

Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use SE 1/4, NE 1/4, SW 1/4 Section 21, T. 44 N., R. 34 E., M.D.B.&M. Describe by legal subdivision, if on unsurveyed land it should be so stated.
