The applicant Victor McCann of Beaver, County of Beaver, State of Utah, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground. Name of stream, lake or other source.

2. The amount of water applied for is 4 second-foot. One second-foot equals 448.83 gals. per min.

R. 49 E., M.D.B. & M. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use S 1/2 Sec. 25, T. 16 S., 49 E. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about Jan. 1 and end about Dec. 31, of each year. Month Month

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled Well, Pump, Motor and Ditches. State manner in which water is to be diverted, whether by dam or other works, whether through pipes, ditches, flumes, or other conduits.
