

AMENDED APPLICATION FOR PERMIT

TO APPROPRIATE THE PUBLIC WATERS OF THE STATE OF NEVADA

The applicant August and Henrietta Bunkowski of Wellington, County of Lyon, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Mound House Quarry Lake. Name of stream, lake or other source.

2. The amount of water applied for is 5.4 second-feet. One second-foot equals 448.83 gals. per min.

(a) If stored in reservoir give number of acre-feet acre-feet

3. The water to be used for Irrigation and domestic. Irrigation, power, mining, manufacturing, domestic, or other use.

4. If use is for:

(a) Irrigation (state number of acres to be irrigated) 350

(b) Stockwater (state number and kinds of animals to be watered)

(c) Other use (describe fully under "No. 11. Remarks")

(d) Power:

(1) Horsepower developed

(2) Point of return of water to stream

5. The water is to be diverted from its source at the following point: in the NW 1/4 NW 1/4 section 25.

T. 16 N., R. 20 E., M. D. B. & M., from which the north 1/4 corner of said section 25, bears N. 54° 47' E., 1878.80 feet. Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land, it should be stated.

6. Place of use Portions of SW 1/4 of section 24 and NE 1/4 of section 25, T. 16 N., R. 20 E., M. D. B. & M., E 1/2 SE 1/2 SW 1/4 Sec. 30; & E 1/2 NW 1/4, W 1/2 NE 1/4, W 1/2 E 1/2 NE 1/4, Sec. 31, T. 16 N., R. 21 E., M. D. B. & M. Describe by legal subdivision, if on unsurveyed land it should be so stated.

7. Use will begin about January 1st and end about December 31st, of each year. Month Month

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. A substantial headgate and measuring device must be installed and maintained to facilitate the measurement and control of water. The State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 5.4 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated.

Actual construction work shall begin on or before February 14, 1965

Proof of commencement of work shall be filed before March 14, 1965

Work must be prosecuted with reasonable diligence and be completed on or before February 14, 1966

Proof of completion of work shall be filed before March 14, 1966

Application of water to beneficial use shall be made on or before February 14, 1969

Proof of the application of water to beneficial use shall be filed on or before March 14, 1969

Map in support of proof of beneficial use shall be filed on or before March 14, 1969

Commencement of work filed FEB 3 1968
