The applicant s Toby Lamuraglia, Ernest L. Hawkins and Charles Perri of Las Vegas, County of Clark, State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Las Vegas Artesian Basin (underground source) Name of stream, lake or other source.

2. The amount of water applied for is 0.6 second-feet One second-foot equals 448.83 gals. per min.

3. The water to be used for Quasi-Municipal (apartments, store buildings, service station) and Domestic Use. Irrigation, power, mining, manufacturing, domestic, or other use.

5. The water is to be diverted from its source at the following point: NE 1/4 NE 1/4 of Section 11, Township 20 South, Range 60 East, M.D.B. & M., or at a point from which the Northeast corner of said Section 11 bears North 61°43'49" East a distance of 636.88 feet.

6. Place of use N 1/2 NE 1/4 NE 1/4 Section 11, Township 20 South, Range 60 East, M.D.B. & M.

7. Use will begin about January 1 and end about December 31, of each year.

8. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) Drilled well, 8 inch casing, with miscellaneous size pipes to points of use.

9. Estimated cost of works..... \$6,000.00  
 10. Estimated time required to construct works..... 60 days  
 11. Remarks..... The water from this well, in conjunction with the water from Well No. 1, will provide water for the maintenance of Approximately 192 apartment units, a swimming pool, approximately 10 store buildings and a service station.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit is issued subject to existing rights and is further subject to revocation if and when water can be furnished by an entity such as a water district or a municipality engaged in furnishing water and is limited to what the well will produce but not to exceed 0.10 c.f.s. A meter must be installed in the discharge pipe line, near the point of diversion, and accurate measurements must be kept of water placed to beneficial use. It is understood that this right must allow for a reasonable lowering of the static water level. The well shall be equipped with a 2-inch opening and an air line for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030; therefore, the State retains the right to regulate the use of the water herein granted at any and all times.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.10 cubic feet per second, but not to exceed 20.1 mg annually from Permits 20825 and 20826 combined.
