The applicant DeVere C. Collingwood of 1811 Andrews Ave. San Jose, County of Santa Clara

State of California, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is an underground source (Well No. 2) Name of stream, lake or other source.

2. The amount of water applied for is 2.50 second-feet One second-foot equals 448.83 gals. per min.
