The applicant W. B. Harman of P. O. Box 1 Orovada, County of Humboldt, State of Nevada

hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.)

1. The source of the proposed appropriation is Underground (Well No. 6) Name of stream, lake or other source.

2. The amount of water applied for is 5.40 second-feet One second-foot equals 448.83 gals. per min.

3. The water to be used for Irrigation and Domestic Irrigation, power, mining, manufacturing, domestic, or other use.

If on unsurveyed land, T. 42 N., R. 37 E., M.D.B. & M. bears S. 0* 04' 00" W. a distance of it should be stated. 5471.53 feet.

6. Place of use S 1/2 SW 1/4 of Sec. 7, N 1/2 SE 1/4 of Sec. 7, N 1/2 SW 1/4 of Sec. 8, and the Describe by legal subdivision, if on unsurveyed land it should be so stated. N 1/2 NW 1/4 of Sec. 18; all in T. 42 N., R. 37 E., M.D.B. & M.
