

APPLICATION FOR PERMISSION TO CHANGE POINT OF DIVERSION, MANNER OF USE AND PLACE OF USE OF THE PUBLIC WATERS OF THE STATE OF NEVADA HERETOFORE APPROPRIATED

The applicant Charles R. Poorbaugh of Eureka, Diamond Valley, County of Eureka State of Nevada, hereby makes application for permission to change the Point of Diversion of water heretofore appropriated under Permit 18667

(Identify existing right by Permit, Certificate, Proof or Claim Nos. If Decreed, give title of Decree and identify right in Decree.)

- 1. The source of water is Underground (Name of stream, lake or other source.)
2. The amount of water to be changed 5.4 cfs. (Second feet, acre feet.)

or at a point from which E 1/2 corner bears N 45° 35' E 1909.80 (Describe as being within a 40-acre subdivision of public survey and by course and distance to a section corner. If on unsurveyed land, it should be stated.)

- 6. The existing point of diversion is located within N. 45° 0' E 70.71 feet from S 1/2 corner SW 1/4 SE 1/4 Sec. 19 T. 22 N R 54 E. MDBSM (If point of diversion is not changed, do not answer.)

- 7. Proposed place of use E 1/2 Sec. 19, T. 22 N. R. 54 E., M.D.B. & M. (Describe by legal subdivisions. If for irrigation state number of acres to be irrigated.)

- 8. Existing place of use No change (Describe by legal subdivisions. If presently used for irrigation, state number of acres irrigated.)

- 9. Use will be from Jan. 1st (Month) to Dec. 31st (Month) of each year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions: This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 18667 is issued subject to the terms and conditions imposed in said permit 18667 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times. The place of use is limited to 158 acres within the SE 1/4 Sec. 19, T. 22 N., R. 54 E.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.79 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.
