State of Nevada, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated. (If applicant is a corporation, give date and place of incorporation; if a copartnership or association, give names of members.) Dec. 31, 1962

1. The source of the proposed appropriation is Dun Glen Creek

5. The water is to be diverted from its source at the following point: NW 1/4 NW 1/4 Sec. 5, T32N, R36E,

MDB&M, or at a point from which the NW cor of said Sec. 5 bears N 45° W., 43 feet.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of cattle served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0280 cubic feet per second, or sufficient water to water 300 head of cattle and 3000 sheep.

Actual construction work shall begin on or before April 20, 1967

Proof of commencement of work shall be filed before May 20, 1967

Work must be prosecuted with reasonable diligence and be completed on or before April 20, 1968

Proof of completion of work shall be filed before May 20, 1968

Application of water to beneficial use shall be made on or before April 20, 1968

Proof of the application of water to beneficial use shall be filed on or before May 20, 1968
