This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner and place of use of the waters of the Truckee River as heretofore granted under Claim 412 (Cochran Ditch), Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.05 cubic feet per second, but not to exceed 9.45 acre-feet per season.

Actual construction work shall begin on or before June 10, 1967

Proof of commencement of work shall be filed before July 10, 1967

Work must be prosecuted with reasonable diligence and be completed on or before June 10, 1968

Proof of completion of work shall be filed before July 10, 1968

Application of water to beneficial use shall be made on or before June 10, 1969
