of water heretofore appropriated under Permit 20831

7. Proposed place of use NW 1/4, N 1/2 SW 1/4, SW 1/4 SW 1/4 of Sec. 31 and NW 1/4, NW 1/4 SW 1/4 Sec. 32, T. 1 N., R. 69 E., M.D.B. & M. 140 acres

8. Existing place of use use not yet developed - applied for use on portions of NE 1/4, N 1/2 SE 1/4, SW 1/4 SE 1/4 Sec. 31, SW 1/4 NW 1/4 and the NW 1/4 SW 1/4 Sec. 32, T. 1 N., R. 69 E., M.D.B. & M.

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the

following limitations and conditions: This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 20831 is issued subject to the terms and conditions imposed in said Permit 20831 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening, an air line and a weir or other type of measuring device at or near the well to facilitate the measurement and control of the water. If well is flowing, a valve must be installed and maintained to prevent waste. The State reserves the right to regulate the use of the water under this proposed change at any and all times. The place of use under this permit is corrected to the following description: NE 1/4, N 1/2 SE 1/4, SW 1/4 SE 1/4 Sec. 31; NW 1/4 and NW 1/4 SW 1/4 Sec. 32, T. 1 N., R. 69 E., M.D.B.&M. (140 acres).

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.2 cubic feet per second, but not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Actual construction work shall begin on or before September 3, 1967. Proof of commencement of work shall be filed before October 3, 1967. Work must be prosecuted with reasonable diligence and be completed on or before September 3, 1968. Proof of completion of work shall be filed before October 3, 1968. Application of water to beneficial use shall be made on or before September 3, 1969. Proof of the application of water to beneficial use shall be filed on or before October 3, 1969. Map in support of proof of beneficial use shall be filed on or before October 3, 1969.
